On the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use

Other matters arising and recommendations

Treatment of written back cheques

During 2021-22 the Council 'wrote back' unpresented cheques totalling £450, recording these in Line 3 Other Income. Proper practice would be to record the write back of unpresented cheques as a reduction in expenditure. As a result, Line 3 is overstated and Line 6 is overstated by £450. The impact on the Council's financial position is £Nil and therefore, I do not consider the impact to be material to the accounts.

We recommend that the Council follows proper practice when writing cheques back in future years.
